Dear Girl Scout Parents,

We invite your Senior (10th grade) or Ambassador Girl Scout to apply for one of five spots as a Shadow Girl as part of our annual Distinguished Women Awards celebration taking place at Preston Hall in Baltimore City. Through the Distinguished Women Shadow program, we offer high school Girl Scouts the chance to explore career interests and learn more about the female leadership experience.

The 45th annual Distinguished Women Awards will take place Wednesday, November 5, 2025. Through this annual fundraiser, we honor five successful women from across central Maryland and provide five high school age Girl Scouts the opportunity to shadow them for a day. As a Distinguished Women Shadow Girl, your daughter will spend the day with one of the honorees, experience first-hand a typical day in her professional role, and learn more about how she navigated her career. The Distinguished Women Honorees and Shadow Girls will share their experiences at the event on November 5, 2025.

Over the years, many Distinguished Women Honorees and Shadow Girls have developed long-term mentor-mentee relationships, providing girls with a source of support as they navigate college and careers. Former Shadow Girls currently pursuing careers in medicine, law, and marketing, value the experience they had through this program. *Shadow Girl Applications must be postmarked or e-mailed by August 23, 2025.

*A committee of GSCM board members and staff will review all applications and invite ten girls to interview in person.

*Interviews will be conducted September 6, 2025 via Zoom. You will receive an email with your interview time.
